Historical Photographs Use Policy (signatures required)

The collections of the Siskiyou County Historical Society are significant and enduring resources for the study and documentation of the history of our county. The Historical Society realizes the visual value of its collections for a wide variety of personal (private study, scholarship, research), educational, commercial (publication), and public relations applications. With this in mind it shall be the policy of the Siskiyou County Historical Society to make available reproductions of its historical photograph collection subject to the following conditions, procedures and fees.

This document outlines the policy for duplicating photographs in the collection of the Siskiyou County Historical Society. Images will be provided in **digital format only**.

The Historical Society does not permit others to reproduce the photographic copy or any facsimile of it. In authorizing the reproduction of works in its collection, the Siskiyou County Historical Society does not surrender its own rights to publish or grant permission for others to do so.

Some of the images in the Historical Society's collection are not available for reproduction and have restrictions for their use indicated by the owner of the original. Every effort has been made to identify those images in advance. A final check of those restrictions will be made prior to processing each order. If it is found that there are restrictions on an image ordered, the full amount paid for production of said image will be refunded.

General Information

All orders must be in writing, or via our website. A signed copy of the **Photo Use Request** must accompany each order along with full *payment* made out *to the Siskiyou County Historical Society*. Order forms may be mailed, completed online, or delivered in person to the Siskiyou County Historical Society.

The Siskiyou County Historical Society does not loan any archival materials including photographs from its collection to the general public.

Copyright Information

Work under copyright may not be reproduced for publication, whether on the internet, or in print media, film, video, YouTube, or any other method without the permission of the author, photographer, or other owner of copyright. The prospective user of any of these images is responsible for obtaining the necessary publication permission.

Delivery of an image by the Siskiyou County Historical Society does not imply any reproduction rights. The Siskiyou County Historical Society does not research copyright clearance. Please note that because we cannot guarantee the copyright status of specific items, use of materials found in our holdings is at your own risk.

Some materials owned by the Siskiyou County Historical Society might be protected by current copyright regulations. Outside the provision of the copyright law known as "fair use," the Historical Society reserves the right to not allow the reproduction of any part of its collections if it feels that said reproduction would be in violation of the copyright law. One time use fees for the publication or exhibition of images will apply but will not be limited to books, magazines, newspaper articles, newsletters, videos, youtube publications, the Internet and websites. In addition to use fees, the Siskiyou County Historical Society requests a copy of any publication in which images appear be donated to the Historical Society to be made available for access at our research library.

Photographic reproductions are provided for the purpose(s) specified in this agreement. Other uses or subsequent reproductions are not allowed.

The user of the photographic images(s) provided through this agreement assumes all responsibility for determining if the images(s) are subject to copyright. The user assumes full responsibility for any copyright infringement or invasion of privacy that may occur as the result of the public use of the images(s).
